2. WCP as a bonus will provide to me a FREE website and an email address once I reach my total purchase of \$ 300.00 worth products.
3. I understand that WCP requires no minimum monthly purchase from me to maintain my status as distributor. However to continued offering the services of free website my account needs to be active. Any website/distributor account with no activity for more than 120 days will be automatically canceled. Re-activation upon review of **WCP**.
4. All **WCP** purchased by me are subject to the warranties and disclaimers applicable to the products at the time of purchase.

I understand that, should I choose to resell product or advance my Marketing Position, I shall be operating as an independent contractor and not an employee, agent, partner or joint venture of **WCP** and that I am not authorized to act on behalf of or to bind **WCP** (or any of its officers, directors, employees or agents). As a Distributor, I will be treated as self-employed and not an employee of **World's Choice Products, Inc** for federal, state and local tax purposes. I will file all returns and reports required by state and federal taxing authorities and pay all federal, state and local taxes arising from my activities as a Distributor.

As an Independent Distributor, I agree to make no false or misleading statements concerning **WCP** or Business Opportunity and understand that if I do so, my distributorship may be terminated by WCP. *I agree to use only materials provided to me by WCP unless I receive written company approval otherwise.* I also agree that all expenses incurred as a distributor will be my sole responsibility.

I understand that as a Distributor, WCP will cheerfully refund my money on all Merchandise returned in salable condition and in its original packaging only if notified within 30 **BUSSINESS DAYS OF PURCHASE**. Refund applies to products only and does not apply to shipping charges, Administrative Fees or Training Fees.
